Report of Committees

Unfinished Business

Director Ramsey brought up the matter of the legal file upload to the HOA website. Secretary Stringer confirmed that she had picked up the USB containing the legal files from the offices of Allison McKenzie, but that she has misplaced it among her personal files. She said she will attempt to locate it before the next board meeting. Once located, she will upload those correspondence and documents that prove Carriage Square Homeowners Association is not a Common Interest Community under the purview of NRS Chapter 81. She will also print the contents of the USB and add the documents to the paper files that she maintains in her function as the board secretary.

New Business

"Little Free Library" Project

Director Ramsey proposed heading a committee to build a little free library (see www.littlefreelibrary.org) at Carriage Square Park. She said she had spoken with member and past Secretary Mary Ellen Komac, who would be a collaborator.
