Minutes

The meeting was called to order by President Karla Reed at 6:04 p.m.

Approval of Minutes

Reed had typographical corrections to the August 8, 2023 minutes. Martinovich moved that the minutes for the August 8, 2023 board meeting, as revised, be approved. Reed seconded and the motion carried.

Report of Secretary

Stringer reported she gave Champion five welcome packets for distribution, which Champion acknowledged having successfully distributed.

Property transfer of 1110 Stagecoach on 8/3/23. The new owners' information on the Assessor's rolls were not up-to-date.

Correspondence since last meeting: 1100 Chaparral's request for new roof was approved; 1101 W. Winnie's request for front window addition (dated 5/2023), was approved.

Expense reimbursement was requested in the amount of \$165.16 for the printing and postage of ballots and dues invoices. Martinovich moved to approve, and Champion seconded. Motion carried.

Old Business

New Business

Elections. Stringer reported that as of 9/19/23, 24 ballots were mailed in. Martinovich confirmed that count. There were no objections to the slate of officers on the ballot, and there was one write-in: Andrew Calhoun nominated himself for Treasurer. Martinovich moved to accept the votes as tendered and to install Andrew Calhoun as Treasurer. Stringer seconded the motion. The motion carried.

CC&Rs review. Stringer said 2024 would be the year the Association will dissolve. Hansen reviewed the CC&Rs and clarified that only by majority vote could the CC&Rs be rescinded. The year 2024 would be the start of another 10-year automatic extension of such CC&Rs.

Dues. Stringer reported receiving 30 checks. In response to the Board's observation that this was much fewer than previous years' receipts, Stringer explained that due to her late mailing, more dues may be forthcoming in the mail. The dues amounted to approximately \$750.

Bank signatories. The banker Stringer spoke to said Reed and Calhoun would need to meet with the banker to submit these official minutes certifying their positions. Reed and Calhoun shall create a new signature card which when completed will cease all Stringer's access to the account.

Transition: Stringer will prepare an inventory of files and Association property such as envelopes to be turned over to Martinovich. She will give Calhoun the post office box key. Martinovich will explore creating a new Board email address.
